

Terms and Conditions **The Summer Kiwi Quiz 2026**

1. The Summer Kiwi Quiz 2026 (the "Competition") is run by Stuff Limited ("Stuff" or "Promoter") under the following participating mastheads; The Post, The Press, Waikato Times, Sunday Star-Times, Southland Times, Timaru Herald, Nelson Mail, Manawatu Standard, Taranaki Daily News, Wairarapa Times-Age (together "the participating mastheads"). Information on how to enter and the prize(s) form part of these terms and conditions. By participating, entrants agree to be bound by these terms and conditions.
2. **ELIGIBILITY:** Employees of Stuff and its related companies and their immediate families, and employees and their immediate families, are not eligible to enter. Entrants must be natural persons and schools, clubs and companies may not enter. Entrants must be New Zealand residents and 18 years or over.

The entry form allows answers to be entered from any day's questions until the competition ends. However, only one correct entry per question, per day, per e-mail address is allowed. Stuff reserves the right in its sole discretion to reject; bulk entries in which it considers software to have been used to generate multiple entries and/or any entry Stuff considers to be fraudulent in any other way.
5. **PRIZE WINNERS:** There will be 5 winners in total who will be selected at random. All winners will receive an e-mail in the week of 09 - 15 February 2026 stating that they have won. The winners will be contacted directly via email. The winners' names will also be announced via email or print.
